SECTION 4: FIRST AID MEASURES

Description of First-aid Measures

General: Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

Skin Contact: Redness, pain, swelling, itching, burning, dryness, and dermatitis. May cause an allergic skin reaction. Repeated or prolonged skin contact may cause dermatitis and defatting.

Eye Contact: May cause slight irritation to eyes.

Ingestion: Ingestion is likely to be harmful or have adverse effects. Ingestion may cause nausea and vomiting. May be fatal if swallowed and enters airways.

Chronic Symptoms: Suspected of causing cancer. Suspected of damaging fertility or the unborn child.

Unsuitable Extinguishing Media: Do not use a heavy water stream. A heavy water stream may spread burning liquid.

Special Hazards Arising From the Substance or Mixture

Fire Hazard: Flammable liquid and vapor.

Explosion Hazard: May form flammable or explosive vapor-air mixture. Vapors are heavier than air and may travel considerable distance to an ignition source and flash back to source of vapors.

Reactivity: Reacts violently with strong oxidizers. Increased risk of fire or explosion.

Advice for Firefighters

Precautionary Measures Fire: Exercise caution when fighting any chemical fire.

Firefighting Instructions: Remove containers from fire area if this can be done without risk. Use water spray or fog for cooling exposed containers. In case of major fire and large quantities: Evacuate area. Fight fire remotely due to the risk of explosion. Do not breathe fumes from fires or vapors from decomposition.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures

General Measures: Keep away from heat, hot surfaces, sparks, open flames, and other ignition sources. No smoking. Use special care to avoid static electric charges. Do not get in eyes, on skin, or on clothing. Do not breathe vapor, mist or spray.

For Non-Emergency Personnel

Protective Equipment: Use appropriate personal protective equipment (PPE).

Emergency Procedures: Evacuate unnecessary personnel. Stop leak if safe to do so.

For Emergency Personnel

Protective Equipment: Equip cleanup crew with proper protection.

Emergency Procedures: Ventilate area. Eliminate ignition sources. Upon arrival at the scene, a first responder is expected to recognize the presence of dangerous goods, protect oneself and the public, secure the area, and call for the assistance of trained personnel as soon as conditions permit.

Environmental Precautions

Prevent entry to sewers and public waters. Avoid release to the environment.

Methods and Materials for Containment and Cleaning Up

For Containment: Contain any spills with dikes or absorbents to prevent migration and entry into sewers or streams. As an immediate precautionary measure, isolate spill or leak area in all directions. Ventilate area.

Methods for Cleaning Up: Eliminate all ignition sources. Ventilate area. Clean up spills immediately and dispose of waste safely. Absorb and/or contain spill with inert material. Do not take up in combustible material such as: saw dust or cellulosic material. Transfer spilled material to a suitable container for disposal. Use only non-sparking tools. Contact competent authorities after a spill.

SECTION 7: HANDLING AND STORAGE

Precautions for Safe Handling

Additional Hazards When Processed: Repeated or prolonged skin contact may cause dermatitis and defatting. Handle empty containers with care because residual vapors are flammable. When mixed with air and exposed to an ignition source, flammable vapors can burn in the open or explode in confined spaces. Being heavier than air, vapors may travel long distances to an ignition source and flash back. Runoff to sewer may cause fire or explosion hazard.

Exposure Controls


