SECTION 4: FIRST AID MEASURES

SECTION 5: FIRE FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media: Dry chemical powder, alcohol-resistant foam, carbon dioxide (CO₂). Water may be ineffective but water should be used to keep fire-exposed container cool.

Unsuitable Extinguishing Media: Do not use a heavy water stream. A heavy water stream may spread burning liquid. Will float and can be reignited on water surface.

Special Hazards Arising From the Substance or Mixture

Fire Hazard: Combustible liquid.

Explosion Hazard: May form flammable or explosive vapor-air mixture. When mixed with air and exposed to an ignition source, flammable vapors can burn in the open or explode in confined spaces. Advice for Firefighters
